

**6.13 MOTOR VEHICLES – Department vehicles – use of Staff car / Departmental Vehicles by the Officers for trips from the place of residence to Office and back beyond 16 kms and upto 25 k.m. – orders – issued.**

**ORDER**

At present the following fixed rates are being charged from the Officers XX for using the staff cars namely:-

In the City of Madras:-

above concession is entitled to be availed by the following Officers as per G.O. Ms.No.165, Public (Motor vehicle, II) department, dt.01-02-85.

- i) Secretary to Government
- ii) Additional Secretary to Government
- iii) Heads of departments.

As per the orders issued in G.O.Ms. No,1686, Home, dt.11-11-91 the concession has been extended to some IInd level officers as noted below, subject to the condition that if any second vehicle is already available in the department.

2. While such is the position, the Examiner of Local Fund account (as Head of Department) has stated that his residence is situated at Pammal and the distance between office and residence (to and fro) is 40kms and requested the Government to extend the concession of using staff car beyond 10 Kms. Due to acute congestion in city for securing accommodation etc., the Government have later issued the House Building Advance Rules and encouraged the Officers to build houses in the outskirts exceeding 15kms without prescribing any limit. Consequent on this, unmindful of these restrictions on use of official vehicles, many officers are living in outskirts of City limits and on this account, rejecting a privilege entitled to a Head of department may not be tested on strong grounds.

3. The Government have therefore examined the proposal in detail as a general question in consultation with the Director, Motor Vehicles Maintenance Department and accordingly direct that the following rates of fixed charges be collected from the Officers for using the Government Vehicles who are entitled to avail such concession.

In the City of Madras

Distance between the place of residence and office	Monthly Charges	Monthly fuel ceiling for each vehicle (both for private and official purpose)
Over 10 Kms and Upto 20 Kms	225.00	160 litres
Over 20 Kms and Upto 25 Kms	300.00	170 litres

3. Other orders are already in force for the use of Government Vehicles and rule 4 of the Tamil Nadu Departmental Vehicles Control Rules, 1976 shall be followed.
