ORDER

In the G.O. first read above, norms for straight condemnation of rayon tyres used in vehicles of Government departments in the city routes as well as mofussil route have been fixed. In the G.O. Second read above, Kilometrage to be covered by Nylon tyres before retreading after 1st, 2nd and 3rd retreading of tyres of various types of vehicles used in Government departments were fixed. But, the kilometrage to be covered for straight condemnation of nylon tyres for city routes and mofussil routes were not fixed. The Director, Motor Vehicles Maintenance Department, Madras has now stated that the cost of nylon tyres is roughly 10% more over the cost of rayon tyres and hence requested to fix the kilometrage for straight condemnation of nylon tyres by allowing 10% increase over and above the Kilometrage fixed by rayon tyres of various types of vehicles used in Government Departments in the G.O. First read above. He has also stated that he has allowed the unit officers to follow the proposed kilometrage for straight condemnation of nylon tyres in anticipation of Government orders and requested to ratify his action.

2. The Government in consultation with Transport Commissioner, Madras accept the above proposal of the Director, Motor Vehicles Maintenance Department, Madras. They direct that the kilometrage shown in the annexure to this orders be adopted for replacement by shown in the annexure to this orders be adopted for replacement by straight condemnation of nylon tyres used in motor vehicles belonging to the departments of Government. They also ratify the action of the Director, Motor Vehicles Maintenance Department in having allowed the unit officers to follow the above norms in anticipation of the orders of Government.
