## Order:

The reorganisation proposals of the Director of Town Panchayats is a result of the recent changes in the Panchayat Raj set up under which the Town Panchayats have been brought under the purview of the District Municipalities Act, 1920 (Tamil Nadu Act V of 1520) as amended by the Tamil Nadu District Municipalities (Amendment) Act, 1994 (Tamil Nadu Act 25 of 1994). There is a resulting change in the responsibilities of the Director of Town Panchayats. Consequently a number of staff changes have been proposed by the Director of Town Panchayats in his Letter read above.

2. The main change is that the entire area will be recorganised into 15 Zones instead of 22 districts as detailed below :-

3. The Government after cereful consideration have decided to reduce the 201 field posts in the Districts into 133. Of the 68 surplus posts 21 posts will be redeployed in the Director of Town Panchayats. Out of the remaining 47 posts which have been identified as surplus 5 shall be disbanded immediately while 42 posts will be declared supernumerary and continued until they fall vacant. Vacancies in the supernumerary categories should not be filled. The restructured staff position in the Directorate of Town Panchayats is given in Annexure – I The restructured staff position in the fifteen new zones is given in Annexure – II The redeployment of staff in respect of Director of Town Panchayats and in District Town Panchayats is given in Annexure – IA and Annexure – IIA respectively.

- 4. Considering the increase in responsibilities of the Directorate due to legislative changes, Government accept the proposal for one Additional Director's post by up gradation of the existing one Joint Director post in addition to one post of Assistant Director upgraded as Joint Director as a special case.
- 5. All the Pay and Accounts Officers, Treasury Officers and Sub-Treasury Officers concerned are authorised to accept the bills presented by the authorities mentioned in the Annexures I and II to this order, for payment, If they are otherwise found correct.
- 6. The Director of Town Panchayats is requested to take immediate action to redeployment staff as mentioned in the Annexures I and II to this order.
