ORDER:

In the Government Order first read above, the Government have constituted a separate Directotrate for the Administration of town Panchayats and Panchayat Townships with effect from 7.5.81. In the Government order second read above, the services of Head Clerk, Revenue Inspector, Junior assistants, Typists and steno Typists in Town Panhayats and Pachayat Townships have been provincialised and in the G.O.third read above, the services of Bill Collector in Town Panchayats and Panchayat Townships have been provincialised. In the G.O.fifth read above, the posts of Bill Collector, grade I and Revenue Inspectors in Town Panchayats Department have been included in category 14 under Rule 2 of the Special Rules for the Tamil Nadu Ministerial Service, along with the posts of Junior Assistants.

- 2. The Director of Town Panchayats has submitted proposals for inclusion of the posts of Bill Collectors, grade I and Revenue Inspector in Rule 12 and 38 of the Special Rules for the Tamil Nadu Ministerial Service. The Government have examined the proposals of the Director of Town Panchayats, and have decided to approve the above proposals.
- 3. The Government accordingly direct that, the post of Bill Collector Grade I and Revenue Inspector in Town Panchayat department he included in Rule 12 (Relating to drawing up of approved list) and in rule 28(relating to age) along with the other posts mentioned in the margin in the Special Rules for the Tamil Nadu Ministerial Service.
- 4. Amendments to the Special Rules for the Tamil Nadu Ministerial Service in this regard will be issued by the Government in the Personnel and Administrative Reforms (D) Department separately.
