The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 13th May, 1981 in respect of Assistants, on the 5th February, 1985 in respect of the posts of Head Clerks and Revenue Inspectors of town Panchayats including Panchayat Townships and on the 16th December 1988 in respect of the post of Bill Collectors (Grade I) of Town Panchayats including Panchayat Townships.

AMENDMENTS

In the said Special Rules:-

- (1) in rule 1,
- (i) after "Category 12A", the following category shall be inserved, namely:-

"Category 12-B

Head Clerks in Town Panchayats including Panchayat Townships"

- (ii) in Category 14, the following expression shall be added at the end, namely:-
- "Revenue Inspectors and Bill Collectors (Grade I) in Town Panchayats including Panchayat Townships"
 - (2) in rule 2, in category 14, the following expression shall be added at the end, namely:-
- "Revenue Inspectors and Bill Collectors (Grade I) in Town Panchayats including Panchayat Townships"
 - (3) in rule 9, after sub-rule (c) the following sub-rule and proviso shall be added namely:-
 - (d) A Bill Collector in the Town Panchayats including Panchayat Townships shall be eligible

for appointment as Junior Assistant in the Town Panchayat Department, if he is qualified and suitable and if he has satisfactorily completed his period of probation as Bill Collector:

Provided that noting contained in this sub-rule shall apply to the Bill Collectors and Record Clerks who were holding the post of Junior Assistant in the town Panchayat Department as on 4th April 1990.

(4) in rule 11, under clause (b), in the proviso, after item (LII) and the entries relating thereto, the following entries shall be added, namely:-

"LIII. Town Panchayats – Unit I – Office of the Director of Town including Panchayats

Panchayat Townships Unit II – All Offices in the districts as a separate Unit

(5) in Annexure I, under "SELECTION CATEGORIES AND GRADES' in 'SECTION A SELECTION CATEGORIES", after the heading "Town and Country Planning Department" and the entries relating thereto the following heading and entries shall be inserted, namely:-

"Town Panchayat Department"

Head Clerks

Assistants

Revenue Inspectors

(6) in Annexure II, after the heading 'TOWN AND COUNTRY PLANNING DEPARTMENT" and the entries relating thereto, the following heading and entries shall be inserted, namely:-

'TOWN PANCHAYAT DEPARTMENT"

- (1) Office of the Director of Town Panchayats
 All members of the service
- Director of Town Panchayats

(2) All Offices in the District
All members of the service

- District Collectors Concerned.

Provided that the authority competent to make therefore from one office to another within the revenue district as an unit shall be the District Collector concerned and from one district to another district shall be the Director of Town Pancahayts.

(7) in Annexure IV, after the heading "TOWN AND COUNTRY PLANNING DEPARTMENT' and the entries relating thereto, the following heading and entries shall be inserted, namely:-

"TOWN PANCHAYAT DEPARTMENT"

Head Clerks - (1) District Office Mannual Test

Assistants - (2) Panchayat Development Account Test

Provided that the holders of the posts of Head Clerks as on 4th April 1990 shall pass the tests within two years from 4th April 1990 failing which they shall not be eligible to draw subsequent increments in the time scale of pay applicable to the post until they pass the said tests. Such ineligibility to draw subsequent increments shall not have the effect of postponing the future increments after they have passed"
