8.6 ESTABLISHMENT-Provincialisation of certain categories of staff in Town Panchayts and Panchayat Townships-Orders-issued.

ORDER:-

In G.O. (Ms) No: 828 R.D. & L.A., dated 7.5.81 the Government have constituted a separate Directorate for Administration of Town Panchayats and Panchayat Townships. This new Department started functioning from 13.5.1981 onwards. As a result, the Executive officers of Town Panchayats who are Government servants, have come under the control of the newly created Directorate of Town Panchayats. The proposals submitted by the Director of Town Panchayats for framing of new service rules for members in the Tamil Nadu Town Panchayats Subordinate Service and for making amendments to the Tamil Nadu Ministerial Service in this regard are under consideration of Government. At present, the Head Clerks, Junior Assistants, Typists including Steno-Typists and Revenue Inspectors of the Town Panchayats and Panchayat Townships are employees of the Local bodies. Hence they cannot be promoted to the post of Executive officers by promotion. They can only be appointed as Executive Officers by direct recruitment subject to possession of educational qualification applicable to direct recruits from open market. With the constitution of a separte department for administration of Town Panchayats, various service associations have been requesting the Government to provincialise certain categories of employees of Town Panchayats such as Typist, Junior Assistant, Revenue Inspector and Head Clerks so as to enable them to enjoy all the benefits now being enjoyed by other members in the Tamil Nadu Panchayat Subordinate Service. In this context the Director of Town Panchayats has proposed the provincialisation of the following categories of staff of Town Panchayats including Panchayat Township.

- 1. Head Clerks
- 2. Revenue Inspectors
- 3. Junior Assistants
- 4. Typists including Steno-Typists.

The Second Pay Commission has also recommended provincialisation of the Town Panchayats and Panchayat Townships in a phased programme. The Administrative Reforms Commission has also recommended that the Ministerial staff in the Town Panchayats may be provincialised.

2. The Government after careful consideration and also after taking into account the position stated in paragraph 1 above, direct that the following categories of staff working in Town Panchayats and Panchayat Townships be provincialised with effect from the date of issue of this order.

Head Clerks

Revenue Inspectors

Junior Assistants
Typists including Steno-Typists.

- 3. The Director of Town Panchayats is requested to send necessary draft amendments to the draft rules already submitted by him in this regard.
- 4. The Town Panchayats and Panchayat Townships will continue to meet the expenditure on pay allowances leave salaray of these staff even after they become Government Servants from their funds as hitherto.
- 5. The usual pensionary contributions applicable to Government Servants, on deputation, shall also be paid by the respective Town Panchayats and Panchayat Townships in respect of these Government Servants also.
- 6. The appointment, discharge for want of vacancy confirmation, seniority, postings and transfer of these staff shall be done by the District Collector with the Revenue District as an unit and that transfers of these staff from one district to another district within the State shall be done by the Director of Town Panchayats.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No: 155/ADS/85 dated 2.2.85.
