ORDER:

In pursuance of the orders issued in the Government order first read above, the Tamil Nadu Public Service Commission had maintained a Reserve List arising from the Group IV examinations conducted for the year 1993-94 and allotted the candidates to various Heads of Departments and Departments of Secretariate for temporary appointments under Rule 10(a)(i) of General Rules for the Tamil Nadu State and Sub ordinate services Rules in the categories of Junior Assistant, Typist and Steno-Typist. The total number of persons so appointed are given below:

Junior Assistant	-	401 (From Reserve List)
Typist	-	279 (From Reserve List)

In the meanwhile, the Tamil Nadu Public Service Commission had conducted a Special Qualifying Examination in 1995 to absorb the persons who have been temporarily appointed in the categories of Junior Assistant, Typist and Steno-Typist from Employment Exchanges and allotted to various Departments for appointment. In anticipation of termination of services in the event of joining of the above said candidates, the persons who were already appointed temporarily from the Reserve list and from Ranking list which is beyond the Reserve List, have moved the Tamil Nadu Administrative Tribunal and High Court at Chennai and obtained stay orders against their termination from service. Hence, they are being continued in service.

3. In its letters second cited, the Tamil Nadu Public Service Commission had recommended for the regularization of services of those persons who were appointed from the Reserve/Banking list from the date of temporary appointment as they have come out successfully in the Preliminary Examination and Main Examination and narrowly missed their chance for inclusion in the Main list owing to non-availability of vacancies. In the representation third read above, the candidates who were appointed from the Reserve List and Ranking list have also represented that their

Services may be regularized as they have put in more than four and half years of Service. In the representation fourth cited, the Tamil Nadu Secretariat Association has also represented that the services of the persons referred to above may be regularized.

4. The Government have examined the above issue in detail and decided to accept the same. They accordingly direct that the services of the persons who were appointed temporarily in the categories of Junior Assistant, Typist and Steno-Typist from the Reserve and from Ranking lists which is beyond the Reserve list arising from the Group – IV examinations held in 1993-94, including the examinations conducted exclusively for the selection to the post of Steno-Typist, be regularized with effect from the dates on which temporary appointments were made in the respective Departments.
