## **ORDER**

In the Government order first read above ban on direct recruitment was imposed resulting in a lot of administrative inconvenience for want of qualified candidates due to non-filling up of vacancies in various posts in the State and Subordinate Services including the vacancies to the filled through the Tamil Nadu Public Service Commission in respect of posts within its purview. The above ban was lifted in the Government Order second read above. Consequently various instructions / clarifications have been issued for filling up of vacancies by fixing realistic estimate of vacancies in the Government orders third & fourth read above and in Letter (Ms.) fifth read above. The authorities empowered as per rules applicable to various posts are taking action to fill up vacancies as ordered above.

- 2. Further, as per rule 10 (a)(i)(1) of General rules for the Tamil Nadu State and Subordinate Servics, temporary appointment to the posts within the purview of the Tamil Nadu Public Service Commission could be made in respect of various posts in the Tamil Nadu State and Subordinate Service from the reserve list mainained by the Tamil Nadu Public Service Commission only.
- 3. The Government have considered in detail the issue of filling up of vacancies in the post of Typist and Steno-Typist Grade-III in the Tamil Nadu Ministerial Service / Tamil Nadu Judicial Ministerial Service as Keeping these posts vacant till such time regular candidate are recruited through the Tamil Nadu Public Service Commission would be extermely difficult.
- 4. The Government have accordingly decided to issue necessary orders for amending the General Rules for the Tamil Nadu State and Subordinate Services and other Special Rules wherever necessary for making temporary appointment to these two categories and to fill up these posts urgently through Commissioner of Technical Education by formulating a scheme in this regard.

- 5. The Government accordingly direct that the posts of Typist and Steno typist Grade-III in the Tamil Nadu Ministerial Service / Tamil Nadu Education by formulating a scheme exclusively for this purpose pending amendment to rules concerned.
- 6. The Commissioner of Technical Education is directed to submit necessary proposals urgently to Government for formulating a scheme in this regard.
- 7. Necessary amendment to General Rules for the Tamil Nadu State and Subordinate Services / Special rules concerned wherever necessary will be issued separately.
