ORDER:

During the Budget Speech for the year 2013-14, the following announcement was made on the floor of the Assembly:-

A Special Solid Waste Management Fund will be constituted with a sum of Rs.100 crore for financing projects in weak Urban Local Bodies during 2013-14.

2. Subsequently, based on the recommendations of 4th State Finance Commission regarding the devolution of resources from the State Government to Local Bodies, orders were issued in the Government Order 1st read above and as amended in Government Order 2nd read above, inter alia that

- "(iii) A fund shall be created for Solid Waste Management activities for all local bodies by pooling an amount of Rs.250.00 crores per annum during the award period. From the above, an amount of Rs.150.00 crores per annum shall be pooled as a separate fund for rural local bodies and Rs.100.00 crores per annum for urban local bodies and shall be released based on need.
 - (iv) The amount of Rs.150.00 crores earmarked to rural local bodies and Rs.100.00 crores to urban local bodies towards Solid Waste Management activities due for the first year of the award period viz., 2012-13 shall be pooled into the fund in 3 annual instalments commencing from the year 2013-14".
- 3. In the Government Order 3rd read above, Government have constituted a Project Sanctioning Committee for approving the projects under Special Solid Waste Management Fund.
- 4. In his letter 4th read above, the Commissioner of Municipal Administration has stated that the first meeting of Project Sanctioning Committee for Special Solid Waste Management Fund was held on 07.10.2013 and the committee has resolved to sanction for implementation of Solid Waste Management Programme at a cost of Rs.48.58 crore in 77 Town Panchayats as detailed below:-

- 5. The Commissioner of Municipal Administration has therefore requested the Government to sanction a grant of Rs.43.728 crore to the Director of Town Panchayats, from the Special Solid Waste Management Fund and also requested to authorize him to draw and disburse the above grant to the Director of Town Panchayats through the Pay and Accounts Office (East) Chennai-8.
- 6. In the letter 5th read above, the Director of Town Panchayats has requested the Government to accord Administrative Sanction for implementation of Solid Waste Management Projects in 77 Town Panchayats at a project cost of Rs.48.58 crore including the 10% of Urban Local Bodies contribution (Grant Rs.43.728 and Town Panchayats contribution Rs.4.859 crore).
- 7. The Government after careful examination of the proposal of the Commissioner of Municipal Administration and the Director of Town Panchayats, have decided to accept the same and hereby accord Administrative Sanction for a sum of Rs. 48.58 crore including the 10% Urban Local Bodies contribution of Rs. 4.859 crore and also accord financial sanction of Rs. 43,72,80,000/- (Rupees forty three crore seventy two lakh eighty thousand only) as grant for implementing Solid Waste Management Projects in 77 Town Panchayats as detailed in para 4 above under Special Solid Waste Management Fund.
- 8. The amount sanctioned in para 7 above shall be debited to the following Head of Account:-

2217 - Urban Development - 80. General - 800 - other Expenditure - I-Non-Plan - AH. Grants for Clean Village Campaign Scheme - 09. Grants-in-aid - 03. Grants for Specific Schemes. (DP Code 2217-80-800-AH-0938)

- 9. The Commissioner of Municipal Administration is authorised to draw and disburse the amount sanctioned in para 7 above to the Director of Town Panchayats through the Pay and Accounts Officer (East), Chennai - 8.
- 10. The Director of Town Panchayats is requested to ensure that funds should be released based on need.
- 11. The orders issues with the concurrence of Finance Department vide its U.O.No. 4607/Fin(MAWS)/2014 Dated: 30.01.2014
