ORDER:

In the Government Order first read above, the Government have accorded Administrative Sanction and released a sum of Rs.757.28 crore [Rs.506.48 Crores in respect of Corporations (except Chennai Corporation) and Municipalities and Rs.250.80 Crore in respect of Town Panchayats] for the implementation of the projects sanctioned under Integrated Urban Development Mission (**IUDM**) scheme for the year 2011-2012.

2. In the Government Order second read above, the Government have accorded sanction and release of an amount of Rs.500.00 Crores to Commissioner of Municipal Administration and Rs.250.00 crore to Director of Town Panchayats for the projects under IUDM for the year 2012-13.

The Government also approved the guidelines for implementation of Integrated Urban Development Mission (IUDM), which includes constitution of **Project Sanctioning and Monitoring Committee** with the following Composition:

Also the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited was appointed as nodal agency for Integrated Urban Development Mission (IUDM). The Commissioner of Municipal Administration, Director of Town Panchayats and Managing Director, Tamil Nadu Water Supply and Drainage Board will send the proposal to the nodal agency. The Nodal Agency will appraise and put up the proposal to the Project Sanctioning and Monitoring Committee for its approval and Administrative Sanction. In the above said Government Order orders have been issued for the creation of Integrated Urban Development Mission Fund (IUDMF) also which will be operated and managed by the Nodal Agency.

3. In Government Order third read above, the Government have accorded administrative sanction for the projects at a total estimated cost of Rs.1455.90 Crores in respect of Commissioner of Municipal Administration and Rs.534.79 Crores in respect of Director of Town Panchayats, out of which the Integrated Urban Development Mission (IUDM) share for 2012-13 is Rs.488.55 Crores and Rs.244.22 crores for Commissioner of Municipal Administration and Director of Town Panchayats respectively.

4. In Government Order fourth read above, the Government have accorded administrative sanction for the projects approved by the Project Sanctioning and Monitoring Committee in its fifth, sixth & seventh Meeting at an estimated cost of Rs.1388.82 Crores in respect of Commissioner of Municipal Administration and Rs.651.56 Crores in respect of Director of Town Panchayats, out of which the Integrated Urban Development Mission (IUDM) share for 2013-14 is Rs.213.78 Crores and Rs.113.64 Crores for Commissioner of Municipal Administration and Director of Town Panchayats respectively.

5. In letter fifth read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that the eighth Meeting of the Project Sanctioning and Monitoring Committee under Integrated Urban Development Mission (IUDM) held on 12.09.2013 and approved various projects for Urban Local Bodies for the year 2013-14 and requested to issue administrative sanction for the projects.

5. The sector wise sanction under Integrated Urban Development Mission (IUDM) to Commissioner of Municipal Administration and Director of Town Panchayats for the year 2013-14 as approved by the Project Sanctioning and Monitoring Committee in its eighth meeting are as detailed below:-
