ORDER:

In the Government Order read above, Government have accorded Administrative Sanction for a sum of Rs.10300.00 lakhs for Improvement of 332 Roads to a length of 425.92 Km. in 281 Town Panchayats under NABARD assistance RIDF XIX for the year 2013-14.

2. In the letter second read above, the General Manager, NABARD, Chennai, has informed that the project proposal at an outlay of Rs.10300.00 lakhs for Improvement of 332 roads to a length of 425.92 Km in 281 Town Panchayats in 31 Districts has been sanctioned, with a loan assistance of Rs.8240.00 lakhs under Rural Infrastructure Development Fund XIX, as per the details given below:-

In the letter third read above, the Director of Town Panchayats has therefore requested the Government to issue necessary orders to make the budget provision and release the amount of Rs.5 50.00 lakhs for Improvement of 332 roads to a length of 425.92 Km in 281 Town Panchayats in 31 Districts for the year 2013-14 being the 50% amount of the sanctioned project under the NABARD (RIDF XIX) scheme at an outlay of Rs.10300.00 lakhs.
- 4. The Government after careful consideration, accept the proposal of the Director of Town Panchayats and direct that out of the administrative sanction accorded for Rs. 103.00 crores in the Government Order read above, the financial sanction of Rs.51,50,00,000/- (Rupees fifty one crore and fifty lakhs only) being the 50% of the administrative sanction for the works for Improvement of 332 roads to a length of 425.92 Km in 281 Town Panchayats in 31 Districts be released under the NABARD assistance RIDF-XIX for the year 2013-2014.
- 5. The amount sanctioned in para 4 above shall be debited under the following Heads of Account:-
 - "4515 00 Capital outlay on other Rural Development Programmes 800 Other Expenditure Schemes in the Twelfth Five Year Plan II State Plan JM NABARD assisted Comprehensive Road Development Programme Town Panchayat Roads 16 Major works (DPC 4515 00 800 JM 1608)"
- 6. Necessary funds has been provided in Revised Estimates 2013-2014.

- 7. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 4 above to the respective Town Panchayats.
