Implementation of Tamil Nadu Infrastructure Project assisted by the Japan Bank of International Co-operation (JBIC) – Apportioning of 302 Million Japanese Yen (about Rs.10.59 crore) allotted for Capacity Building and Detailed Project Report Preparation between the Directorate of Municipal Administration and the Directorate of Town Panchayats – Orders – Issued.

ORDER:

In the G.O. first read above, administrative sanction has been accorded for the implementation of JBIC assisted Tamil Nadu Infrastructure Project (TNUIP) at a total cost of 9824 Million Japanese Yen (about Rs.344.70 crores) and pass on the JBIC line of credit of 8551 Million Japanese Yen by the State Government to TNUDF / JBIC Grant Fund-1 / JBIC Grant Fund-II.

- 2. In the letter second read above, the Director of Municipal Administration has stated that in the G.O. first read above, the Government has allotted 302 Million Japanese Yen (about Rs.10.59 crore) for the Capacity Building and Preparation of Detailed Project Report by the Director of Municipal Administration and the Director Town Panchayats. However, this amount has not been apportioned between the Director of Municipal Administration and the Director of Town Panchayats for utilization. Therefore, the Government was requested to pass orders apportioning the amount of Rs. 10.59 crore allotted for Capacity Building and Preparation of Detailed Project Report in the above G.O. under the JBIC assisted Tamil Nadu Urban Infrastructure Project between the Director of Municipal Administration and Director of Town Panchayats so that action may initiated by both the offices to utilize this amount.
- 3. The Director of Municipal Administration has also stated that since the amount of Rs. 10.59 crore has been allotted by the Government for Capacity Building initiatives it will be appropriate if the population of the ULBs and the

Town Panchayats (as per 2001 census is taken as a basis for apportioning the amount between the Director of Municipal Administration and the Director of Town Panchayats.

- 4. The Director of Municipal Administration has therefore requested the Government to allot Rs. 6,83,39,816/- from out of the allocation of Rs. 10.59 crore to the Director of Municipal Administration and the balance amount of Rs. 3,75,60,184/- to the Director of Town Panchayats on the basis of the population (2001 census) of both the ULBs (except Chennai) and the Town Panchayats. The above proposal was approved by the Empowered Committee.
- 5. The Government after careful examination of the proposal of the Director of Municipal Administration allocate Rs. 6,83,39,868/- (Rupee six crore eighty three lakhs thirty nine thousand eight hundred and sixty eight only) from out of Rs. 10.59 crore to the Director of Municipal Administration and the balance amount of Rs. 3,75,60,132/- (Rupees three crores seventy five lakh sixty thousand one hundred and thirty two only) to the Director of Town Panchayats on the basis of the population (2001 census) of the corporations (except Chennai), Municipalities and the Town Panchayats as approved by the Empowered Committee.
- 6. This order issues with the concurrence of Finance Department vide its U.No. 20963/MAWS/2010, dated 3.06.2010.
