### ORDER:

The Director of Town Panchayats in his letter read above has stated that there are 7598 number of households in the Elampillai Town Panchayat. The Elampillai Eri is of an extent about 36 acres with an Ayacut of about 5 Acres and situated in the survey No.23/3. This Eri was maintained by the Veerapandy Panchayat Union and handed over to the Elampillai Town Panchayat. At present all the sewerage water like black water (from septic tank), Grey water (from other domestic use) are directly led into this Eri. Thus, Polluted the entire Eri and also the ground water of the Town Panchayat. Hence, it has been proposed to implement the Liquid Resource Management in Elampillai Town Panchayat at an estimated cost of Rs.236.75 lakhs.

- 3. The Director of Town Panchayats has therefore requested the Government to sanction a sum of Rs.236.75 lakhs to implement the Liquid Resource Management in Elampillai Town Panchayat in Salem District under Part-II Scheme for 2014-15.
- 4. The Government, after careful examination, accept the proposal of Director of Town Panchayats and sanction a sum of Rs.236.75 lakh (Rupees Two Hundred and Thirty Six lakhs and Seventy Five Thousand only) towards implementation of Liquid Resource Management in Elampillai Town Panchayat, Salem District, under Part-II Schemes for the year 2014-15.

- 5. The amount sanctioned in para 4 above shall be debited to the following head of account:-
  - "2217 URBAN DEVELOPMENT 05 other Urban Development Schemes 800 other Expenditure Schemes in the Twelfth Five Year Plan II State Plan JZ Establishment of Liquid Resource Management works in Town Panchayats 09 Grants in Aid 03 Grants for specific Schemes. [DPC 2217-05 -800 JZ 0934] "
- 6. The Director of Town Panchayats is authorised to draw and disburse the amount sanctioned in para 4 above, based on the need at the appropriate stage to the concerned Town Panchayat. He is also requested to send a completion report in this regard to the Government.
