ORDER:

In the Government Order second and third read above, the Government have sanctioned and released a sum of Rs. 3594.00 lakhs as General Basic grant to the Town Panchayats as first instalment and of Rs.211.73 lakhs as balance grant for Ist instalment of General Basic Grants under Thirteenth Finance Commission grants for the year 2011-12. In the Government order fourth read above, Government have also released a sum of Rs.3805.73 lakhs as 2nd installment of Basic Grant for the year 2011-12 under the recommendations of the Thirteenth Finance Commission.

2. In the letter fifth read above, the Director of Town Panchayats has stated that the Government of India has conveyed the approval for payment of Rs.32480.00 lakhs as IInd instalment of General Basic Grant and Rs.3490.17 lakhs as General Performance Grant for the year 2011-12 based on the recommendations of the 13th Finance Commission. He has further stated that based on the release of first instalment grant of Rs.31193 lakhs by Government of India, the IInd instalment grant of Rs.31193 lakhs towards General Basic Grant has already been released by the

Government in advance to the respective Local Bodies pending receipt of grants from Government of India. Since the Government of India release is higher, the balance grant of Rs.1287 lakhs has to be released to the respective Local Bodies.

- 3. In the letter fifth read above, the Director of Town Panchayats has also requested the Government to release a sum of Rs.1,57,14,552/- (Rupees One crore fifty seven lakhs and fourteen thousands five hundred and fifty two only) being the balance of second instalment of General Basic grant and Rs.4,77,84,866/- (Rupees Four crores Seventy seven lakhs eighty four thousands eight hundreds and sixty six only) being General Performance Grant for the year 2011-2012 under the recommendation of the Thirteenth Finance Commission and has also requested the Government, to authorise to draw and disburse the above amount.
- 4. The Government, after careful examination of the proposal of Director of Town Panchayats, sanction and release a sum of Rs.1,57,14,552/- (Rupees One crore fifty seven lakhs and fourteen thousands five hundred and fifty two only) being the balance of second instalment of General Basic grant and Rs.4,77,84,866/- (Rupees Four crores Seventy seven lakhs eighty four thousands eight hundreds and sixty six only) being General Performance Grant for the year 2011-2012 under the recommendations of Thirteenth Finance Commission.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

- 6. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 4 above to all the Town Panchayats. He is also requested to instruct the Town Panchayats for the utilisation of the grant as per the revised guidelines issued by the Government in the Government Order first read above.

- 7. Further the Director of Town Panchayats is also directed to furnish the Utilisation Certificate for the amount sanctioned in para 4 above to the Government early, so as to forward the same to Government of India.
