### **ORDER:**

Town Panchayat Administration is striving for the uplift of the standard of living of the people in Town Panchayats by providing better civic services to the public such as drinking water, street lights, sanitation, Solid Waste Management, road connectivity, Drain and pavements etc., Apart from that, construction and maintenance of bus stands, community hall and markets are also undertaken by Town Panchayats.

2. Due to rapid growth of population and non-availability of Community halls in the Town Panchayat areas, people are much needed to have community hall to perform various functions and activities in their locality. Most of the people used to go adjacent towns for kalyana mandapam in function time. The Director of Town Panchayats has therefore proposed to construct community hall in Veeravanallur Town Panchayat in Tirunelveli District at a cost of Rs.42.00 lakhs and to facilitate the existing community hall in Kaveripattinam Town Panchayat in Krishnagiri District with additional facilities by constructing an auditorium in the first floor of the Community Hall at a cost of Rs.42.00 lakhs which will augement the income of Town Panchayats under Part-II scheme for the year 2014-15.

3. The Government after careful examination, accept the proposal of Director of Town Panchayats and sanction a sum of Rs.84.00 lakhs (Rupees Eighty Four Lakhs only) for construction of community hall in Veeravanallur Town Panchayat and also an auditorium in the first floor

of the existing community hall in Kaveripattinum Town Panchayat, under Part-II Scheme for the year 2014-15.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-
