**ORDER:**

Under the award of 13<sup>th</sup> Central Finance Commission, a total sum of Rs.36274.26 lakhs have been released to the Municipal Corporations, Municipalities and Town Panchyats as basic grants, so far, for the year

2014-15, vide the Government Orders first to fourth read above, as mentioned below:

2. Following are the details of the funds received from Government of India under the award of the 13<sup>th</sup> Central Finance Commission for the year 2014-15:-

3. Therefore, the State Government has to release a balance sum of Rs. 33,80,03,000 (Rs.39654.29 lakhs – Rs.36274.26 lakhs) to the ULBs for the year 2014-15 as basic grants under the award of 13<sup>th</sup> Central Finance Commission.

4. Accordingly, the Government sanction a sum of Rs.23,99,82,130/- to the Corporations and Municipalities and a sum of Rs.9,80,20,870/- to the Town Panchayats totalling a sum of **Rs.33,80,03,000 (Rupees Thirty three crore eighty lakh and three thousand only)** to the Corporations, Municipalities and Town Panchayats as basic grants for the year 2014-15 under the award of 13<sup>th</sup> Central Finance Commission as below:
