In the Government Order third read above, orders have been issued on the devolution of funds to local bodies at 9.5% from State's Own Tax Revenue for the year 2009-10 based on the recommendations of Third State Finance Commission and as accepted by the Government. It was also ordered therein that the devolution of funds for the remaining years of the award period would be issued during the years to follow.

- 2. The Government have earlier decided to devolve funds at 10% from State's Own Tax Revenue, to the local bodies for the year 2010-11 which was communicated in the Explanatory Memorandum on the Action Taken on the recommendations of Third State Finance Commission placed in the Legislative Assembly on 10.05.2007.
 - 3. Accordingly, the Government issue the following orders:-
 - The devolution of funds to the local bodies from State's Own Tax Revenue for the year 2010-11 shall be at 10%.
 - ii) This order shall take effect from 01.04.2010.
 - iii) The ratio for the devolution of funds for the last year of the award period of Third State Finance Commission shall be issued during the year to follow.
