#### ORDER:

In the letter read above, the Director of Town Panchayats has requested to appoint 15 Executive Officers to the post of Assistant Director of Town Panchayats by recruitment by transfer by relaxing the rule 4 of the Adhoc Rules framed in the Government Order first cited and as amended in the Government Order second cited, for the 13 persons who have not completed the prescribed qualification for the post of Assistant Director of Town Panchayats and the other two persons in SI.Nos.8 and 9. (Thiru S.Ravichandar and S.R.Rajendran) who have completed the prescribed qualification, under rule 10 (a) (i) of the Tamil Nadu State and Subordinate Services Rules.

The above proposal of the Director of Town Panchayats has been examined in detail by the Government and accept to appoint the 15 Executive Officers to the post of Assistant Director of Town Panchayats by recruitment by transfer by relaxing the rule 4 of the Adhoc Rules for the 13 persons who have not completed the prescribed

qualification for the post of Assistant Director of Town Panchayats and the other two persons in Sl.No.8 and 9. (Thiru. S. Ravichandar and S.R. Rajendran) who have completed the prescribed qualification, under rule 10 (a) (i) of the Tamil Nadu State and Subordinate Services Rules, subject to the condition that their appointment is purely temporary and their seniority will be confirmed when the State Level Seniority of Executive Officer is finalized.

Accordingly in exercise of powers conferred by General Rule 48 of Tamil Nadu State and Subordinate Services Rules under Volume I / Part II of Tamil Nadu Service Manual 1987, the Governor of Tamil Nadu hereby relaxes the rule 4 of the adhoc Rules for the 13 persons who have not completed the prescribed qualification for the post of Assistant Director of Town Panchayats and the other two persons in Sl.No.8 and 9. (Thiru. S. Ravichandar and S.R. Rajendran) who have completed the prescribed qualification, under rule 10 (a) (i) of the Tamil Nadu State and Subordinate Services Rules, subject to the condition that their appointment is purely temporary and their seniority will be confirmed when the State Level Seniority of Executive Officer is finalized.
