ORDER:-

While moving the Demand No.34, for the year 2012-13, the Hon'ble Minister for Municipal Administration and Rural Development made the following announcement on the Floor of the Assembly:-

்மாண்புமிகு முதலமைச்சர் அவர்களின் ஆணைப்படி, 143 பேரூராட்சிகளில் 234 ஊரணிகள் ரூ.54.32 கோடி மதிபீட்டில் மேம்படுத்தப்படும். இப்பணி தேசிய வேளாண்மை மற்றும் ஊரக வளர்ச்சி வங்கியின் ஊரகக் கட்டமைப்பு மேம்பாட்டு நிதி மூலம் மேற்கொள்ளப்படும். ஊரணிகளில் தூர்வாருதல், கரைகளை பலப்படுத்துதல், ஊரணிக்குள் சிறு குட்டை அமைத்தல், நீர்வரத்து வாய்க்கால் மற்றும் உபரிநீர் வெளியேறும் வாய்க்கால் சீரமைத்தல், நடைபாதையமைத்தல், மின்விளக்கு வசதி ஏற்படுத்துதல் மற்றும் ஊரணிகளின் பாதுகாப்பிற்காக வேலியமைத்தல் போன்ற பணிகள் இதில் அடங்கும். இதன்மூலம், நிலத்தடி நீர் செறிவூட்டப்படுவதுடன் ஊரணிகள் அசுத்தமாவதிலிருந்தும், ஆக்கிரமிப்பிலிருந்தும் பாதுகாக்கப்படும்."

2. In pursuance to the above announcement, the Director of Town Panchayats has stated that the Town Panchayats have been witnessing high growth rate in the recent years and hence they are in need of greater financial assistance to provide better civic services to the public and the services rendered by them ranges from Drinking Water to Solid Waste Management. The Town Panchayats Department has requested a sum of Rs. 360.36 crore covering major sectors of Drinking water, and Comprehensive development of Ooranies and Roads. The Director of Town Panchayats has further stated that the Oorani development scheme has been taken up with a view to strengthen water recharging structures with all its attending benefits and requested to allot Rs.54.3225 crore for comprehensive development of 234 Ooranies and recommend the proposal to NABARD for approval and sanction.

- 3. The Director of Town Panchayats has also stated that, at present, the Town Panchayats have been allotted a sum of Rs. 434.38 crore under various schemes including IUDM for infrastructure development and this allotment is too minimal compared to the demand of Rs.8285.52 crore. Therefore he has proposed to access financial assistance from NABARD either under RIDF XVIII or RIDF XVIII for sectoral development.
- 4. After detailed examination of the proposal of the Director of Town Panchayats, the Government have decided to accept it and forwarded the same to NABARD for loan assistance under RIDF XVIII for the year 2012-13.
- 5. The NABARD has sanctioned the proposal of the Director of Town Panchayats for comprehensive development of 234 Ooranies at an estimated cost of Rs.54.3225 crore in 143 Town Panchayats on the 127th Project Sanctioning Committee meeting held on 19.07.2012.
- 6. The Government after careful consideration, accord administrative sanction for comprehensive development of 234 Ooranies in 143 Town Panchayats at an estimated cost of Rs.54,32,25,000/- (Rupees Fifty four crore thirty two lakhs and twenty five thousand only) as annexed to this order under NABARD assisted RIDF XVIII Scheme for the year 2012-2013 (NABARD loan Rs.46.1741 crore + State Share Rs.8.1484 crore)
- 7. This order issues with the concurrence of Finance Department vide its U.O. No.262/JS(PM)/2012, dated 23.08.2012.
