ORDER:-

The Government have fixed a cap of Rs.200.00 crore being the allocation for Town Panchayats Department for implementation of scheme like roads, culvert, ooranies, sanitary complexes and slaughter houses at cost of Rs.200.00 crore with the assistance of NABARD under RIDF XVIII for the year 2012-2013 and requested the Director of Town Panchyats to send the revised proposal accordingly.

- 2. Pursuant to that, the Director of Town Panchayats has sent a consolidated proposal for Comprehensive Oorani Development, Improvement of roads and construction of Sanitary Complexes in Town Panchayats at a cost of Rs.200.53 crore. The Director of Town Panchayats has further stated that the Oorani development scheme has been taken up with a view to strengthen water recharging structures with all its attended benefits. Similarly, construction of toilets has been proposed keeping in view the avowed objective of the Government to make Tamil Nadu an "Open defecation free State" and roads and other items have been proposed considering huge requirement under the respective sectors. He has therefore requested the orders of Government thereon.
- 3. The proposals were examined by the Government and the same was forwarded to NABARD for loan assistance under RIDF XVIII for the year 2012-2013. In respect of the works of Comprehensive Development of 234 Ooranies in 143 Town Panchayats at a cost of Rs.54.32 crore with NABARD assistance under RIDF XVIII, the proposal has already been examined and orders will be issued separately. For the remaining works of improvement of 366 roads in 292 Town Panchayats at a estimated

cost of Rs.101.0040 crore and improvement of 376 sanitary complexes in 244 Town Panchayats at a cost of Rs.45.20 crore, the NABARD has sanctioned the loan assistance under RIDF XVIII for the year 2012-2013, in the 127th Project Sanctioning Committee meeting held on 19.07.2012.

- 4. The Government, after careful consideration accord administrative sanction for a sum of Rs.146,20,40,000/- (Rupees one hundered and forty six crore twenty lakh and forty thousand only) for taking up of 366 works for improvement of roads in 292 Town Panchayats at cost of Rs.101.0040 crore (Rupees one hundered and one crore and forty thousand only) and 376 works for construction of sanitary complexes in 244 Town Panchayats at a cost of Rs.45.20 crore (Rupees forty five crore and twenty lakh only) as annexed to this order with the NABARD assistance under RIDF XVIII for the year 2012-2013. (NABARD loan Rs.119.224 crore + State share Rs.26.980 crore).
