Announcement 2012-13 – Town Panchayats Administration – Administrative Sanction for implementation of Under Ground Sewerage Scheme in 5 Town Panchayats at an estimated cost of Rs.166.38 crores - Orders issued.

Order:-

While moving the Demand No.34 for the year 2012-13, Hon'ble Minister for Municipal Administration and Rural Development has made an announcement on the floor of the Legislative Assembly as follows:-

பேரூராட்சிகளிலும் படிப்படியாக பாதாள சாக்கடைத் திட்டத்தை ''அனைத்து செயலப்படுத்த மாண்புமிகு முதலமைச்சர் அவர்கள் ஆணையிட்டுள்ளார்கள். அதனப்படி 2012−13ஆம் ஆண்டு, மாமல⊡லபுரம் (விரிவாக்கப் பகுதி), திருப்போரூர், பொன⊡னேரி, ஆலங்காயம், செங்கம், பென□னாகரம், காவேரிப்பட்டினம், ஜலகண்டாபுரம், ஆலம்பாளையம், பெருந்துறை, குன்[னத்தூர், பெரியநாயக்கன[பாளையம், பெண்ணாடம், உளுந்தூர்பேட்டை, வல⊡லம், வேளாங்கண்ணி, நீடாமங்கலம், மண்ணச்சநல⊡லூர், குரும்பலூர், ஆயக்குடி, புகளூர், பழனிச்செட்டிப்பட்டி, தமிழ∏நாடு காகித பரவை, ച്ഛെலை முதுகுளத்தூர், கானாடுகாத்தான□, சே<u>த்த</u>ூர், சாம்பவார்வடகரை மற \Box றும் ஆழ \Box வார்திருநகரி ஆகிய பேரூராட்சிகளில□ ரு.755.98 கோடி மதிப்பீட்டில□ பாதாள சாக்கடைத் திட்டம் மேற்கோள் விர்படும்".

2. As a sequence to the above announcement, the Director of Town Panchayats has sent a proposal for execution of Under Ground Sewerage Scheme in 5 Town Panchayats viz Chengam, Perundurai, Pennadam, Velankanni, Palanichettipatty with the following funding pattern:-

The Director of Town Panchayats has also requested to sanction 50% amount, on the estimate cost of Rs.166.38 crore i.e. Rs.61.08 crore, excluding road relaying cost as 70% loan and 30% grant under KfW and the amount of Rs.22.11 crore for relaying of roads which would be met out either from TURIF or IUDM in the subsequent years.

- 3. In G.O read above, the Government have accorded administrative sanction for a sum of Rs.244.22 crore in respect of Town Panchayats Department for implementation of various projects including Under Ground Sewerage Scheme in the above 5 Town Panchayats at an estimated cost of Rs.166.38 crore and out of this amount, a sum of Rs.13.884 crore has been sanctioned for the above Under Ground Sewerage Scheme in 5 Town Panchayats under IUDM for the year 2012-13.
- 4. The Government after careful consideration, accord administrative sanction for implementation of Under Ground Sewerage Scheme in 5 Town Panchayats including the road laying cost at an estimated cost of Rs.166,38,00,000/-(Rupees one hundred and sixty six crore and thirty eight lakhs) as detailed in paras 2 3 above with the funding pattern of 50% amount of

Rs. 83.19 crore under IUDM and 50% amount of Rs. 83.19 crore under Kfw funding which is in the pattern as 70% loan and 30% grant and the amount of Rs.22.11 crore as detailed in para 2 above for laying of roads would be met out either from TURIF or IUDM in the subsequent years.

5. This order issues with the concurrence of Finance Department vide its U.O. No.62905/ Finance/ MAWS/2012, dated; 14.11.2012 .
