In the G.O first read above, the Government have issued orders for creating an Infrastructure Development Fund in the name of Tamil Nadu Urban Infrastructure Development Renewal Fund (TNUIDRF) and Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has been appointed as Fund Manager. In the above G.O., it has also been ordered that the Fund Manager shall be entitled to receive a Management Fee and the fee shall be payable on quarterly basis. The fee can be received from time to time, subject to mutual negotiation between the Government and Fund Manager.

In the letter second read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, has stated that, the TUFIDCO was requested to send a proposal to Government separately for hits approval based on the present scenario in operation/management of TNUIDRF and Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has proposed the Management Fee as detailed below:-
 - (a) The Government may approve the Management Fee as 0.1% of total funds managed by Tamil Nadu Urban Finance and Infrastructure

Development Corporation Limited excluding quantum of amount sanctioned and disbursed to the scheme implementing agency.
