In the Government Order first read above, the Government have sanctioned and released a sum of Rs.42,00,03,500/- as 1st instalment of General Basic Grant under the recommendation of 13th finance commission for the year 2012-13.

- 2. Now the Director of Town Panchayats in his letter second read above has requested the Government to release a sum of Rs.42,00,03,500/- as second installment of General Basic Grant under the recommendation of 13th Finance Commission for the year 2012-13.
- 3. The Government, after careful examination of the proposal of the Director of Town Panchayats, sanction and release a sum of Rs. 42,00,03,500/- (Rupees Forty two crore three thousand and five hundred only) as second instalment of General Basic Grant of Thirteenth Finance Commission for the year 2012-13.
- 4. The amount sanctioned in para 3 above shall be debited in to the following head of Account:-

"3604-00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 193 – Assistance to Nagar Panchayats / Notified Area Committees or equivalent thereof - Schemes in the Twelfth Five Year Plan - II State Plan -JD - Grants to Town Panchayats as per the recommendations of 13th Finance Commission Controlled by Director of Town Panchayat – 09 – Grants-in-aid-01Grants for Current Expenditure. (DP Code: 3604 00 193 JD 0913)".

- 5. Necessary additional funds of Rs.157.15 lakhs over and above the BE 2012-13 provisions will be provided in RE / FMA, 2012-2013 to meet the expenditure sanctioned in para 3 above. The Director of Town Panchayats is authorized to incur the expenditure.
- 6. The Director of Town Panchayats is requested to include the expenditure sanctioned in para 3 above, while sending the budget proposals for RE / FMA, 2012-2013 to Finance Department.
- 7. This order issues with the concurrence of Finance Department vide its U.O. No.58873/FIN (MAWS)/2012, dated 14.11.2012 with ASL No.1584 (One thousand five hundred and eighty four).
