Order:

The Commissioner of Town Panchayats in the letter second read above has stated that the Government have sanctioned a sum of Rs.3210.26 lakhs under Twelfth Finance Commission Grants for the year 2008–2009 and released a sum of Rs.1605.13 lakhs as first instalment in the G.O. read above. He has also stated that the first instalment grant amount has been drawn and disbursed to all the Town Panchayats as per guidelines. He has furnished necessary Utilisation Certificate for the first instalment of Twelfth Finance Commission grants to the Town Panchayats for the year 2008 - 2009 and has also furnished the Districtwise allocation details for the release of second instalment of Rs.1605.13 lakhs . He has, therefore, requested that the amount of Rs.1605.13 lakhs may be sanctioned as second instalment of Twelfth Finance Commission grant for the year 2008 -2009.

2. After careful examination of the proposal and anticipating the receipt of second instalment from Government of India, sanction is accorded for the release of the second instalment grant of Rs.1605.13 lakhs (Rupees Sixteen Crores and five lakhs and thirteen thousand only) to the Town Panchayats under local body grants recommended by Twelfth Finance Commission for the year 2008 -2009.

3.The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

“3604 – 00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 193 – Assistance to Nagar Panchayats/ Notified Area Committees or equivalent thereof – Schemes in the Eleventh Five Year Plan - II State Plan - JC Grants to Town Panchayats as per the recommendation of Twelfth Finance Commission controlled by Director of Town Panchayats 09 – Grants – in – aid – 01 Grants for Current Expenditure. (D.P.Code 3604 00 193 JC 0915)”.

4. The Commissioner of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 2 above to all the Town Panchayats based on 2001 Census population (75% of the grants) and fiscal collection (25% of the grant) as already decided by the High Level Committee. The Commissioner of Town Panchayats shall instruct the Town Panchayats to utilize the grants towards the following items as approved by the High Level Committee, earlier:

| iii) Roads, Data base : | 20% |
| iv) Electricity Charges : | 10% |

The Commissioner of Town Panchayats is also requested to furnish the Utilisation Certificate for the amount sanctioned in para 2 above to the Government early so as to furnish the same to Government of India.
