The Director of Town Panchayats in his letter read above has stated that the Government have provided a sum of Rs.6202.00 lakhs to Town Panchayats as grants recommended under Thirteenth Finance Commission for the year 2010-2011. He has furnished the District wise allocation details for the release of first installment of Rs.3101.00 lakhs. He has, therefore, requested to release the amount of Rs.3101.00 lakhs as first installment of Thirteenth Finance Commission grant for the year 2010-2011 to Town Panchayats.

- 2. The Government after careful examination of the proposal of Director of Town Panchayats, sanction and release a sum of Rs. Rs.3101.00 lakhs (Rupees Thirty one crore one lakhs only) to the Town Panchayats as first installment of grants recommended by Thirteenth Finance Commission for the year 2010-2011 under General Basic Grant.
- 3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:-
  - "3664 00 Compensation and Assignments to Local Bodies and Panchayat Raj Institutions 193 Assistance to Nagar Panchayats / Notified Area Committees or equivalent thereof II State Plan JD Grants to Town Panchayats as per the recommendation of Thirteenth Finance Commission controlled by Director of Town Panchayats-09 Grants-in-aid 01 Grants for current Expenditure (D.P.Code 3604 00 193 JD 0913)"

- 4. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 2 above to all Town Panchayats based on 2001 Census population (75% of the grants) and fiscal collection (25% of the grant) as already decided by the High Level Committee during 12<sup>th</sup> Finance award period. The Director of Town Panchayats shall instruct the Town Panchayats to utilize the grants towards the following items as approved by the High Level Committee, earlier:
  - i. Solid Waste Management 50%
  - ii., Liquid waste, storm water drainage and sewerage 20%
  - iii. Roads, database 20%
  - iv. Electricity Charges 10%

The Director of Town Panchayats is also requested to furnish the Utilisation Certificate for the amount sanctioned in para 2 above to the Government early, so as to furnish the same to Government of India. The Government also direct that the recommendations of the 13<sup>th</sup> Finance Commission to be strictly adhered to while utilizing the grant recommended by it.252228 and 2023 stayed and move to note and entired.
