The Director of Town Panchayats had requested to accord necessary revised administrative sanction for the estimated cost indicated against each of the Town Panchayats in the table under para 3 above for providing water supply improvement scheme to the 7 Town panchayats in Coimbatore District under Urban Infrastructure Development Scheme for Small and Medium Towns to be executed by Tamil Nadu Water Supply and Drainage Board.

The Government after careful examination in modification of the earlier orders issued in the G.O. first read above accord revised administrative sanction for implementation of Water Supply improvement schemes under Urban Infrastructure Development Scheme for Small and Medium Towns at the cost as detailed below subject to the condition that the difference of cost between original administrative sanction accorded in the G.O. first read above and the revised administrative sanction now accorded will be met by the concerned Town panchayats including 10% of the Urban Local Bodies contribution to be obtained as Ioan assistance from Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.
