ORDER:

Town Panchayats are playing a major role in Solid Waste Management for Collection, Segregation, compost and manure production. The compost yards in Sholavandan and Alanganallur Town Panchayats are not having any basic infrastructure facilities which resulted in trespassing by the public and by the antisocial elements. If these compost yards are improved by way of construction of compound wall and other facilities, it will facilitate in keeping the town panchayat clean and green and also it will enable them to augment their income by way of production of manure and also recycling of plastic waste.

- 2. In order to improve the compost yards in Sholavandan and Alanganallur Town Panchayats in Madurai District, the Director of Town Panchayat has requested the Government to sanction a sum of Rs.30,00,000 under Part-II Scheme for the year 2012-2013.
- 3. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.30,00,000/- (Rupees Thirty lakh only) for Compost Yard in two Town Panchayats under Part-II Scheme for the year 2012-2013, as per the annexure to this Government Order.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-

"2515-00 – Other Rural Development Programmes – 800 – Other Expenditure - Schemes in the Twelfth Five Year Plan - II State Plan - KJ – Assistance to Town Panchayat for infrastructure Development - 09 – Grants – in – Aid - 03 – Grants for specific schemes"

- 4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 3 above, based on the need at the appropriate stage to the concerned Town Panchayats. The Director of Town Panchayat is also requested to send a completion report in this regard to Government.
