ORDER:

In the Government order second read above, the Government accepted the proposal of Director of Town Panchayats, and accorded administrative sanction for the proposal for strengthening of 684 roads (VRS) in Town Panchayats at a total cost of Rs.11356.49 lakhs, (Rupees one hundred and thirteen crore fifty six lakhs and forty nine thousand only) with the loan assistance of Rs.9085.19 lakhs from NABARD under RIDF.XV and State Government contribution of Rs.2271.30 lakhs.

2. In the letter third read above, the Director of Town Panchayats has stated that a sum of Rs.45.00 crore has been made as Budget provision for 2010-2011 and requested to release the same for Strengthening and Upgradation of 684 Roads in Town Panchayats under NABARD-RIDF.XV Scheme.

3. The Government after careful examination, accept the proposal of the Director of Town Panchayats in para 2 above and accorded sanction to release a sum of Rs.45.00 crore (Rupees forty five crore only) for Strengthening and Upgradation of 684 Roads in 398 Town Panchayats with assistance from NABARD-RIDF XV Scheme.

4. The amount sanctioned in para 5 above shall be debited to the following head of account:-

" 4515 00 - Capital Outlay on other Rural Development Programmes - II State Plan - 800 Other Expenditure - JM NABARD Assisted Comprehensive Road Development Programme - Town Panchayat Roads - 16 - Major Works" (D.P.Code 4515 00 800 JM 1608)

5. The Director of Town Panchayats is authorised to draw the amount sanctioned in para 3 above and disburse the same for Strengthening and Upgradation of 684 Roads in 398 Town Panchayats with assistance from NABARD-RIDF XV Scheme.
