ORDER:

In Town Panchayats, the present services are mostly delivered on the basis of manually prepared records which involve cumbersome and time consuming process and the software now available in the department has invited applications to Birth / Death and Scheme Monitoring System. The Centrally Sponsored Schemes such as JnNURM, UIDSSMT, IHSDP and BSUP have added to the work load in Town Panchayats and they have a set of preconditions for implementation of various reforms including e-Governance initiatives.

2. In order to implement online web based system in all the Town Panchayats / Assistant Directorate of Town Panchayats / Directorate of Town Panchayats, the Director of Town Panchayats has proposed to procure hardware for all Town Panchayats, Zonal Offices and Directorate of Town Panchayats at a total cost of Rs.195.00 lakhs.

3. The Government after careful examination, accept the proposal of Director of Town Panchayats and sanction a total sum of Rs.1,95,00,000/- (Rupees One Crore and Ninety Five lakh only) to purchase of computers for Town Panchayat Offices (529), Assistant Directorate of Town Panchayats (16) and Directorate of Town Panchayats (10) under Part – II Scheme for the year 2012-2013, as per the annexure to this Government Order.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:-

“2515 – 00 – Other Rural Development Programmes - 001 – Direction and Administration - I – Non Plan - AI , Directorate of Town Panchayats - 76 – Computer and Accessories - 01. Purchase”

(DPC. 2515 – 00 – 001 – AI – 7616)”

5. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats and the procedure as per the Tamil Nadu Transparency in Tenders Act and Rules should be followed while procuring the computers and accessories etc. The Director of Town Panchayat is also requested to send a report to the Government in this regard .
