### ORDER:

Town Panchayats are having marketing and trade activities. Neighbouring village Panchayats are depending upon the areas of town Panchayats for marketing their products and for trade activities. To strengthen these hubs, construction of shopping complexes in town Panchayats is absolutely necessary which would facilitate in augmenting the income of Town Panchayats. The Director of Town Panchayat has therefore proposed to take up construction of 3 shopping complexes in 3 Town Panchayats and market improvements at a cost of Rs.39.00 lakh under Part-II Scheme for the year 2012-2013.

2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.39,00,000/- (Rupees Thirty Nine lakh only) for construction of Shopping Complex and Market Improvement in 3 Town Panchayats under Part – II Schemes for the year 2012-2013, as per the annexure to this Government Order.

3. The amount sanctioned in para 2 above shall be debited into the following head of account:-

“2515 – 00 – Other Rural Development Programmes - 800 – Other Expenditure- Schemes in the Twelfth Five Year Plan - II State Plan - KJ – Assistance to Town Panchayat for infrastructure Development - 09 – Grants – in – Aid - 03 – Grants for specific schemes”

4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats. He is also requested to send completion report to the Government.
