ORDER:

In Ramanathapuram District, Mudukulathur Town Panchayat is one of the Town Panchayats having population 13,126. There is a weekly market and at present animals are slaughtered in the open space which is in hygienic and harmful to the population. The Director of Town Panchayat has therefore proposed to construct a modern slaughter house at weekly market at a cost of Rs.20.00 lakhs under Part-II Scheme for the year 2012-2013.

- 2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a sum of Rs.20,00,000/- (Rupees Twenty lakhs only) for construction of Slaughter House at weekly market in Mudukulathur Town Panchayat, Ramanathapuram District under Part II Scheme for the year 2012-2013.
- 3. The amount sanctioned in para 2 above shall be debited to the following head of account:-

"4217 – Capital outlay on Urban Development - 60 – Other Urban Development Scheme - 800 – Other Expenditure - Schemes in the Twelfth Five Year Plan - II State Plan - JK – Construction of Slaughter houses in Town Panchayats - 16 – Major works" (DPC. 4217 – 60 – 800 – JK – 1601)

- 4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 2 above, for the said purpose. He is also requested to send a completion report to the Government in this regard.
