ORDER:

In 7 Town Panchayats, the existing water supply is in-sufficient and minimum requirement of 70 LPCD could not be provided to the public. In order to provide the above minimum requirement to the public, the Director of Town Panchayat has proposed to improve the existing water supply schemes in 7 Town Panchayats at a cost of Rs. 143.00 lakhs under Part-II Scheme for the year 2012-2013.

- 2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.1,43,00,000/- (Rupees One Crore and Fourty Three lakhs only) for the improvement of existing water supply schemes in 7 Town Panchayats under Part II Scheme for the year 2012-2013, as per the annexure to this Government Order.
- 3. The amount sanctioned in para 2 above shall be debited into the following head of account:-

"2515 – 00 – Other Rural Development Programmes - 800 – Other Expenditure-KW – Improvement of Water Supply Schemes in Town Panchayats - 09 – Grants – in – Aid - 03 – Grants for specific schemes"

- 4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats. He is also requested to send a completion report to the Government in this regard.
