ORDER:

In the letter second read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that in the letter first read above interalia, the Government of India had released Rs.16292.77 lakhs towards second instalment for 11 projects sanctioned under Jawaharlal Nehru National Urban Renewal Mission –UIG. The corresponding State's share works out to Rs.6613.68 lakhs, totaling to Rs.22906.45 lakhs. The details are as follows.

2. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to release second instalment of both the Central and State's share of Rs.22906.45 lakhs for the above projects and transfer the amount to P.D. Account which is in the name of Tamil Nadu Urban Infrastructure Development and Renewal Fund.

3. The Government after careful examination of the request of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited in para 2 above sanction and release Rs. 22906.45 lakhs (Rupees two hundred and twenty nine crores six lakhs and forty five thousands only) (Government of India share Rs. 16292.77 lakhs + Government of Tamil Nadu share Rs. 6613.68 lakhs) towards second instalment amount for the 11 projects indicated in the table under para 1 above

4. The amount sanctioned in para 3 above shall be debited to the following Head of account:

" 2217 Urban Development – 05. Other Urban Development Scheme – 800. Other Expenditure – Schemes in the Eleventh Five year Plan –II – State Plan – JL – Jawaharlal Nehru National Urban Renewal Mission (JNNURM) – Submission for Urban Infrastructure and Governance – 09. Grants-in-aid – 01. Grants for current expenditure. (D.P.Code No.2217 05 800 JL 0914)".

5. The amount shall not be paid in cash, but contra credited to the following Head of Account:

"K. Deposits and Advances – (b) Deposits not bearing interest - 8443.00 Civil Deposits – 800. Other Deposits – DA. Deposits of Tamil Nadu Urban Infrastructure Development and Renewal Fund. (D.P. Code 8443 00 800 DA 000A(Receipts)". (DPC 8443 -00-800 – DA-0000) (Outgo).

6. Necessary Funds will be provided in RE/FMA – 2009-10. However this should be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2009-10. Pending provision of necessary additional funds in the RE/FMA 2009-10,the Director of Municipal Administration is authorized to draw and disburse the amount sanctioned in para 3 above by means of an Account Payee Cheque in favour of Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited to the P.D. Account which is in the name of "Tamil Nadu Urban Finance and Infrastructure Development and Renewal Fund" and credit the same to the above Deposit Account.

7. The Director of Municipal Administration is requested to include the above expenditure while sending proposals for RE/FMA 2009-2010 and to send necessary explanatory notes for including the expenditure in the Supplementary Estimates 2009-2010, to Finance (BG.I/MA&WS) Department at the appropriate time without fail.
