ORDER:

Due to fast urbanization, people are using the Town Panchayat areas for marketing, employment health care etc and the number of buses plying in Town Panchayats have increased. The existing bus stands are lacking infrastructure facilities and their improvement will facilitate in augmenting the income of town Panchayats. The Director of Town Panchayat has therefore proposed to improve the infrastructure facilities in 3 bus stands by way of construction of building, compound wall and construction of cement concrete pavement at cost of Rs.70.00 lakhs under Part-II scheme for the year 2012-13.

2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.70,00,000/- (Rupees Seventy lakhs only) to improve the infrastructure facilities in bus stand in 3 Town Panchayats under Part – II Scheme for the year 2012-2013, as per the annexure to this Government Order.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:-

“2515 – 00 – Other Rural Development Programmes - 800 – Other Expenditure- Schemes in the Twelfth Five Year Plan - II – State Plan - KJ – Assistance to Town Panchayat for infrastructure Development - 09 – Grants – in – Aid - 03 – Grants for specific schemes”

4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats. The Director of Town Panchayat is also requested to send completion report to the Government.
