The Director of Municipal Administration has requested the Government to release the amount of Rs.1875.64 lakhs sanctioned by the Government of India as 2<sup>nd</sup> Installment and corresponding State Share of Rs.1564.94 lakhs totally Rs. 3440.58 lakhs (Government of India Rs.1875.64 lakhs+Government of Tamil Nadu Rs.1564.94 lakhs) to Director of Municipal Administration's (BSUP) SB account No. 30120509278 maintained at S.B.I, Chepauk Branch.

5. The Government after careful examination accept the proposal of the Director of Municipal Administration at para 4 above. Accordingly the Government sanction and release the amount of Rs.1875.64 lakhs sanctioned by Government of India as second instalment and corresponding State share of Rs.1564.94 lakhs totaling Rs.3440.58 lakhs (Rupees thirty four crores forty lakhs and fifty eight thousand only) to the ULBs mentioned in para 2above.
