ORDER:

The office buildings of 10 Town Panchayats in Kancheepuram, Vellore, Dharmapuri, Erode, Villupuram, Coimbatore, Thiruvavur, Trichy, Tirunelveli and Kanniyakumari Districts are in a dilapidated condition and they have to be demolished and new office buildings have to be constructed considering the fact of these offices have public interface. Further, in most of the cases, meeting halls are not available and elected representatives are finding it more difficult in discharging their functions. The Director of Town Panchayat has therefore proposed to construct new office buildings in 10 Town Panchayats at a total cost of Rs.317.00 lakhs.

2. The Government after careful examination, accept the proposal of Director of Town Panchayat and sanction a total sum of Rs.3,17,00,000/- (Rupees Three Crore and Seventeen lakh only) for construction of 10 New Office Buildings for Town Panchayats and Assistant Director of Town Panchayats under Part – II Scheme for the year 2012-2013, as per the annexure to this Government Order.

3. The amount sanctioned in para 2 above shall be debited to the following head of account:-

“4515 – 00 – Capital outlay on Other Rural Development Programmes - 800 – Other Expenditure - Schemes in the Twelfth Five Year Plan - II State Plan - JW – Construction of Office Buildings for Town Panchayats - 16. Major Works”

4. The Director of Town Panchayat is authorized to draw and disburse the amount sanctioned in para 2 above, based on the need at the appropriate stage to the concerned Town Panchayats and they should follow the process of the Tamil Nadu Transparency in Tenders Act and Rules while entrusting the works. The Director of Town Panchayat is also requested to send completion report to the Government.
