### ORDER:

In the G.O. first read above, among others, the Government have released a sum of Rs. 194.40 lakhs towards 1st installment of GOI + GOTN share to Managadu, Tiruneermalai and Minjur Town panchayats. In the G.O. second read above, among others, a sum of Rs. 194.40 lakhs had been released towards second installment of GOI share and GOTN share to Mangadu, Tiruneermalai and Minjur Town Panchayats. In the G.O. third read above interalia, a sum of Rs. 2264.17 lakhs had been released to Vilangudi, Paravai, Sholavandan, Anaiyur, Periyayanakanpalayam and Saravanampatti Town Panchayats towards 1st installment of GOI + GOTN share for implementation of scheme under BSUP.

2. In the letter fifth read above the Director of Municipal Administration has stated that Government of India has sanctioned and released a sum of Rs. 331.87 lakhs to the ULBs as detailed below:-
