#### ORDER:

In the G.O. read above, Government have accorded administrative sanction for comprehensive development of 234 Ooranies in 143 Town Panchayats at an estimated cost of Rs.54,32,25,000/- (Rupees Fifty four crore thirty two lakhs and twenty five thousand only) under NABARD assisted RIDF XVIII Scheme for the year 2012-2013 (NABARD loan Rs.46.1741 crore + State Share Rs.8.1484 crore).

2. In the letter second read above, the General Manager, NABARD, Chennai – 34, has informed that the project proposal at an outlay of Rs.5432.25 lakhs for Comprehensive development of 234 Ooranies in 143 Town Panchayats in 27 District has been sanctioned, with a loan assistance of Rs.4617.41 lakhs under Rural Infrastructure Development Fund XVIII, as per the details given below:-

- 3. In the letter 3<sup>rd</sup> read above, the Director of Town Panchayats has therefore requested the Government to issue necessary orders to make the budget provision and release the amount of Rs.2716.125 lakhs for the year 2012-13 being the 50% amount of the sanctioned project under the NABARD (RIDF XVIII) scheme at an outlay of Rs.5432.25 lakhs.
- 4. The Government after careful consideration, accept the proposal of the Director of Town Panchayats and direct that out of the administrative sanction accorded in the Government Order read above, the financial sanction of Rs.27,16,12,500 (Rupees twenty seven crores sixteen lakhs twelve thousand and five hundred only) being the 50% of the administrative sanction for the works of comprehensive development of 234 Ooranies in 143 Town Panchayats be released under the NABARD assistance RIDF-XVIII for the year 2012-2013.

5. The amount sanctioned in para 4 above shall be debited under the following new head of Account:-

"4515-00 Capital outlay on other Rural Development Programmes -800 Other Expenditure - Schemes in the Twelfth Five Year Plan - II State Plan - JZ - Comprehensive development of Ooranies and Town Panchayats with loan assistance from NABARD - 16 major works (DPC 4515-00-800- JZ 1602)"

- 6. The Director of Town Panchayats is authorized to draw and disburse the amount sanctioned in para 4 above to the respective Town Panchayats.
