ORDER:

In the Government Order second read above, a sum of Rs.33.00 lakhs was sanctioned for the implementing various Gap Filling Infrastructure schemes in Tirunelveli District under Western Ghats Development Programme during the year 2009-2010.

2. For the year 2010-2011, the Director of Town Panchayats has sent proposal to Government for implementation of various Gap Filling schemes in Tirunelvei District under Western Ghats Development Programme. After detailed examination, the proposal to the tune of Rs.62.00 lakhs has been recommended to Union Planning Commission, Government of India for approval. In the letter fourth read above, the Union Planning Commission, Government of India has communicated its approval of Rs.62.00 lakhs for the implementation of various schemes under Western Ghats Development Programme in Town Panchayats for the year 2010-2011.

- 3) The Government, after careful consideration, accord sanction to incur an expenditure of Rs.62.00 lakhs (Rupees Sixty two lakhs only) for the implementation of schemes of Gap Filling Infrastructure sector in Sivagiri, Town Panchayat at Tirunelveli District under Western Ghats Development Programme for the year 2010-2011 as detailed in the Annexure to this order.
- 4) The expenditure sanctioned in para-3 above shall be debited under the following head of account:-

"2551- Hill Areas – 01.Western Ghats -108. Village and Small Industries-Schemes in the Eleventh Five Year Plan - II. State Plan – JJ. Implementation of various Gap Filling Infrastructure Schemes under Western Ghats Development Programme - 09. Grants-in-Aid – 03. Grants for Specific Schemes".(DPC No. 2551 01 108 JJ 0933)

- 5) The expenditure sanctioned above shall not constitute as New Service since this scheme has already been treated as New Service in the previous financial year and acted upon on that year. Necessary funds will be provided in RE/FMA 2010-2011. Pending provision of such funds in RE/FMA 2010-2011, the Director of Town Panchayats is authorized to draw and disburse the amount sanctioned above. However, it shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2010-2011. The Director of Town Panchayats shall send necessary Supplementary notes to Finance (BG.I) Department at the appropriate time and also include the amount sanctioned in para 3 above while sending proposal to Finance Department at the time of finalisation RE/FMA 2010-2011.
- 6) The Director of Town Panchayats is requested to send the monthly Progress Report by 15th of every month.
- 7) It shall be ensured that detailed estimates with Project Report are available for each item of work prior to disbursement and a copy submitted to the Collector of the concerned district in advance for monitoring. Where relevant, a baseline survey, user needs and beneficiary identification along with relevant details of watershed features, land use and likely impacts should form part of the project report so submitted. In cases where works are dependent on site selection with public participation, the details with photographic evidence and supporting remote sensing maps should be provided in the Project report. Finally, upon completion of the project, a completion report with photographs and factual report of use, impact, beneficiary feed back should be sent along with financial details of utilization and balance surrendered including for works accounted under Letter of Credit method. In the case of beneficiaries of inputs, Plant Protection Equipment or other equipment, a certificate shall also be provided that the beneficiary has not received this benefit during the previous years and is therefore, eligible for the incentive to adopt technology.

- 8) As ordered in the Government order first read above, the Director of Town Panchayats and the District Collector, Tirunelveli shall watch the implementation of the above schemes.
- 9) This order issues with the concurrence of Finance Department vide its U.O.No.32335/MA&WS/2010, dated 28.06.2010 and Additional Sanction Ledger No.356 (Three hundred and fifty six).
