ORDER:

The District level set up of Town Panchayats administration has been re-organised with effect from 1.6.1994 and the entire State has been divided into 15 zones, for the purpose of Town Panchayats Administration and each zone is headed by a District Town Panchayat Officer. In the G.O.third read above, the post of District Town Panchayats Officers cum-Personal Assistant to Collector (Town Panchayats) have been appointed as Assistant Director of Town Panchayats. The Government have now decided that an amendment be issued to Adhoc rules issued for the post of Joint Director of Town Panchayats in the G.O.second read above.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the ad-hoc rules for the temporary post of Joint Director of Town Panchayats published with Rural Development Department Notification No.SRO B-91/93 at page 95 of Part III - Section 1(b) of the Tamil Nadu Government Gazette dated the 9th June, 1993.

2. The amendment hereby made shall be deemed to have come into force on 3rd February, 1995.

AMENDMENT

In the said Rules, in rules 3 and 4, for the words, "District Town Panchayat Officer", the words "Assistant Director of Town Panchayats" shall be substituted.
