ORDER:

In the G.O.first read above, the existing one post of Joint Director of Town Panchayats was upgraded as Additional Director of Town Panchayats. The Government have now examined the proposal sent by the Director of Town Panchayats for framing of adhoc-rules for the post of Additional Director in the Directorate of Town Panchayats and decided to accept it.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The rules hereby made shall be deemed to have come into force on the 25th November 1994.

RULES

The General and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu Panchayat Development Service shall apply to the holder of the temporary post of Additional Director of Town Panchayats in the office of the Director of Town Panchayats, subject to the modifications specified in the following rules.

2. Constitution .- The post shall constitute a separate category in the said service.

3. Appointment .- Appointment to the post shall be made by promotion from among the holders of the post of Joint Director of Town Panchayats; or by deputation from among the holders of the posts of Additional Director of Municipal Administration or District Revenue Officer. The tenure of service of the deputationist shall be for one year only and the period of the tenure of the service of the deputationist shall be extended beyond one year if considered necessary.

4. Qualification .- No person shall be eligible for appointment to the post by promotion unless he had rendered service in the category of Joint Director of Town Panchayats for a period of not less than one year.

5. Pay .- There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs.4500-150-5700 in the pre-revised scale of pay.


