ORDER:

Based on the recommendation of the Fourth Pay Commission, orders were issued by the Government in Finance Department fixing the same scale of pay for the post of Bill Collectors and Junior Assistants working in Town Panchayats (i.e.Rs 610-20-730-25-955-30-1075). Subsequently, based on the One Man Committee, the Government, in the Government Order read above, issued orders as follows:-

- i) No person is eligible for appointment as Bill Collector/Tax Collector in Local bodies by direct recruitment unless he/she possesses 10th Std., Passed Qualification.
- ii) The Bill Collectors and Tax Collectors in Local bodies be placed on scales of pay as shown below:

- i) The posts of Bill Collectors and Junior Assistants will be made inter transferable.
 - In the above Government Order, it has also been requested to take action for issue of amendment to the relevant service rules for making the post of Junior Assistants and Bill Collectors working in Town Panchayats as inter-changeable.
- 2) The Director of Town Panchayats in his letter read above, has stated that since the services of the Junior Assistants, Head Clerks, Revenue Inspectors and Typists of the Town Panchayats have been provincialised (vide G.O.Ms.No: 64 R.D. dt. 5.2.85) and since the pay scales of Bill Collectors and Junior Assistants have been equated as per the Fourth Pay Commission and since these two posts have been declared inter-changeable, it is necessary that the

- services of the Bill Collectors are also to be provincialised. The Tamil Nadu Bill Collecors Association has also made representation on this.
- 3) The Government, after careful consideration and also taking into account the orders issued in the Government Order read above, direct that the services of the Bill Collectors working in Town Panchayats and Panchayat Townships, be provincialised with effect from the date of issue of this order.
- 4) The amendment to the relevant service rules, for making the posts of Junior Assistants and the posts of Bill Collectors working in Town Panchayats who have passed SSLC as interchangeable will issue separately.
- 5) The Town Panchayats and Panchayat Townships will continue to meet the expenditure on pay, allowance, leave salary of the Bill Collectors even after they become Government Servants from their funds as done hitherto. The pensionary contributions shall also be paid by the respective Town Panchayats and Panchayat Townships.
- 6) The appointments, discharge for want of vacancy confirmation, seniority, postings and transfers of this staff shall be done by the District Collector concerned within the Revenue District as an unit and transfers of this staff from one District to another district within the state shall be done by the Director of Town Panchayats.
- 7) This order issues with the concurrence of the Finance Department vide its U.O.No:4795/FS/P/88 dt. 22.11.88.
