New Health Insurance Scheme – Extension of the scheme to willing institutions registered under the Tamil Nadu Registration of Societies Act, 1975 – Orders – Issued.

ORDER:

In the Government Order seventh read above, it has been ordered among other things that the employees of certain category of organisations which are willing to bear the employers' share of the premium and are willing to collect the employees' contribution and where there is no financial liability befalling on the State Budget may be included under the coverage of the New Health Insurance Scheme.

2.The organisations listed in the Annexure to this order have sent specific proposals for extension of the coverage of the New Health Insurance Scheme to their employees and have furnished their willingness to contribute the employers' share of the premium payable to the insurance company as per the provisions of the scheme.

3.It is hereby ordered that the organisations/institutions listed in the Annexure to this order be covered under the New Health Insurance Scheme with immediate effect. The orders issued under the New Health Insurance Scheme shall be applicable to the employees covered in this order. The Chief Executive Officers of the organisations/institutions listed in the Annexure to this order shall arrange to upload the details of the employees covered under the scheme on the web-site of the Treasuries and Accounts Department viz. <http://www.tn.gov.in/Karuvoolam>.

4.As per the orders issued in para 4 of the Government order first read above the annual premium (The employees' subscription and the employer's contribution and the tax amount) shall be credited within one month to the following sub head of account:

5.The Director of Treasuries and Accounts shall be the estimating, reconciling and controlling authority in respect of the head of account mentioned above. The Director of Treasuries and Accounts shall reckon the employees covered under this Government Order also while sending proposals based on the number of Identity Cards for sanction of release of premium amounts due to the insurance company from time to time. The Director of Treasuries and Accounts is requested to open the head of account mentioned above in the books of accounts.
