It is proposed to prepare a panel for the year 2023- 2024 for appointment as Assistant Accounts Officer in Class IV of Tamil Nadu State Treasuries and Accounts Service by promotion from among the holders of the post of Additional Sub Treasury Officers / Sub Treasury Officers / Superintendents.

2. To consider for inclusion in the panel one must possess the following qualifications as on 15-06-2023.

- a) Must possess the minimum General Educational qualification
- b) Must have passed Account Test for Subordinate Officers Part I and Part II
- c) Must have passed the Departmental Test for Subordinate Officers in Treasuries and Accounts Department.
- d) i) Must have passed Accountancy Lower Grade conducted by the Technical Education Department
  - (or) ii) Provided that a person who possesses B. Com. Degree (10+2+3 / 11+1+3) need not be required to pass the Accountancy Lower / Higher Grade Examination.

#### Note:

- 1. B.Com under double degree program is not acceptable at present on par with regular B.Com course.
- 2. If the individual possess B.Com. Degree the certificates of 10<sup>th</sup>, 12<sup>th</sup> or 11<sup>th</sup> PUC and B.Com degree certificates should be pasted in the Service Register along with a copy of the Mark Statement (3 years) of B.Com Degree, to know the pattern of study.

- iii) B.A Corporate Secretaryship awarded by University of Madras (G.O (Ms.) No.232 Higher Education (K2) Department Dated:18.11.2016)
- iv) B.A Corporate Secretary ship awarded by Bharathidasan University (Government in Finance (T&A-1) Department letter No.8739/T &A-1/2018—1, Dated: 27.09.2019)
- v) Passed M.Com (Post graduation) with B.B.A as Bachelor degree in Commerce. (Govt. Fin. Dept Letter No.48161/T&A-I/2015 Dated 02.11.2015)
- vi) Passed B.B.M degree awarded by University of Madras (Govt. Fin. Dept Letter No.18369/T&A-I/2019 dated 27.02.2020)
- vii) B.Com (double Degree) Distance Education Mode (One Year) Awarded by Annamalai University (G.O (Ms.) No.235 Higher Education (K1) Department Dated:28.08.2023
- 3. It is requested that a list of persons who satisfy the above qualifications and completed probation in the category of Superintendent as on **15-06-2023** and included in the <u>Superintendent Panel up to the year 2019 2020</u> may be sent so as to reach this office <u>on or before 15.11.2024.</u>
- 4. The particulars of each individual may be furnished separately in the Proforma "A" specimen of which is enclosed. The Service Registers with up to date entries and Record sheets up to the period ending 30.06.2023 may also be sent. If there are no qualified persons, a "NIL REPORT" should be sent without fail. A declaration as enclosed in the Proforma "B" may also be obtained from the individuals concerned and sent. In case of persons who satisfy the qualifications but not willing to be considered for the post of Assistant Accounts Officer shall furnish necessary relinquishment, either temporarily or permanently, under General Rule 47 of Tamil Nadu State and Subordinate Services vide Proforma "C" enclosed and be sent to this office. No request for relinquishment will be entertained after inclusion of the name in the panel.
- 5. It is also informed that the list should also include the names of the individuals who are on deputation on Foreign Service and in other Government departments. The individuals whose names were deferred in the previous year panels of Assistant Accounts Officer should also be included in the list subject to eligibility / fitness and their Service Register and Record Sheet with up to date entries should be sent to this office without fail. The individuals who have temporarily relinquished previously and completed the period of relinquishment as on 15.06.2023 should also be considered and necessary proposals shall be sent.

- 6. All the particulars furnished in the Proforma should be flagged on the relevant pages where the entries are made in the Service Register of the individual.
- 7. A certificate to the effect that the proposals are submitted to the Commissionerate in respect of all eligible persons and that no qualified one has been left over in the proposals shall be furnished. If there is no eligible person for consideration for the panel, a "NIL" report shall also be furnished without fail.
