It is proposed to prepare a panel for the year 2019 - 2020 for appointment to the post of Assistant Accounts Officer in Class IV of Treasuries and Accounts State Service by transfer from among the persons holding the posts of Superintendents, Commercial Accountants or Auditors borne on Tamil Nadu Ministerial Service in the scale of pay applicable to Superintendents (PB – 2: Rs. 9300 – 34800 + GP 4800 / -) as above or from among persons holding similar supervisory posts carrying scale of pay not less than that of Superintendents in any other service or from among the holders of the post of Commercial Accountants in the Tamil Nadu Ministerial Service.

(2) To consider for inclusion in the panel, one must possess the following qualifications as on 15.06.2019.

- a) Must possess the minimum General Educational qualification
- b) Must have passed Account Test for Subordinate Officers Part I and Part II
- i) Must have passed Accountancy Lower Grade conducted by the Technical Education Department.

(or)

- ii) Provided that a person who possesses B. Com. Degree (10+2+3 / 11+1+3) need not be required to pass the Accountancy Lower / Higher Grade Examination. **Note:**
- 1. B.Com under double degree program is not acceptable at present on par with regular B.Com course.
- 2. If the individual possess B.Com. Degree the certificates of 10th, 12th

# or 11<sup>th</sup> PUC and B.Com degree certificates should be pasted in the Service Register along with a copy of the Mark Statement (3 years) of B.Com Degree, to know the pattern of study.

- iii) B.A Corporate Secretaryship awarded by University of Madras (G.O (Ms.) No.232 Higher Education (K2) Department Dated:18.11.2016)
- iv) B.A Corporate Secretaryship awarded by Bharathidasan University (Government in Finance (T&A-1) Department letter No.8739/T &A-1/2018—1 Dated: 27.09.2019)
- v) Passed M.Com (Post graduation) with B.B.A as Bachelor degree in Commerce.
  - (Govt. Fin. Dept Letter No.48161/T&A-I/2015 dated 02.11.2015)
- vi) Passed B.B.M degree awarded by University of Madras (Govt. Fin. Dept Letter No.18369/T&A-I/2019 dated 27.02.2020)
- d) Must have worked in sections dealing with the subjects relating to accounts, audit, budgeting or control of expenditure for a period of not less than five years as Regular Superintendent, Accountant or Auditor borne on the Tamil Nadu Ministerial Service or in any other similar supervisory posts carrying pay not less than that of the Superintendent in other service or as Commercial Accountant in the Tamil Nadu Ministerial Service and
- e) Must be an approved probationer in the category from which appointment is made or in any of the lower categories in that service to which he was recruited.
- (3) It is, therefore, requested that eligible candidates may be sponsored from your department. The details in respect of the candidates may be furnished in Proforma "A" & "B" for each candidate separately, along with their Service Registers and Record Sheets updated to the end of 30.06.2019. The Proforma "D" may be furnished by the sponsoring authority and enclosed with the proposals sent.
- (4) It is pointed out that the aspiring individuals have to discharge his / her duties both as controlling officer or drawing officer and at times as audit officer too during the rest of their career in the Treasuries and Accounts Department. Therefore his / her knowledge in preparation, distribution of budget including Final modified appropriation is necessary. He/ She should able to visualize through his experience, the lapses that may occur in drawal of claims no matter it is intentional or not to safeguard the Government interest in the transaction.
- (5) It is therefore insisted that the actual experience alone in respect of the individual should be furnished. The **table entries** as below should be made in the Service Register of the individuals under **proper attestation of the competent authority** as it form one of the basic qualification for consideration and inclusion in the panel for the Assistant Accounts Officer.

- (6) The list of candidates may kindly be sent so as to reach this office in complete shape on or before.15.05.2020 and proposals received after that date will not be considered.
- (7) Further, as instructed in Govt. letter No. 14958/T&A-I/2019-1, Dated 30.05.2019, it is requested to confirm as to whether the deputation posts of Asst. Accounts Officer, Accounts Officer and Chief Accounts Officer in your department are exclusively reserved for Treasuries and Accounts Department along with post sanctioned G.Os so as to arrive the combined cadre strength and to calculate your departmental representation for consideration of your proposal.

If proposals are not received on or before the said date in complete shape, it will be construed that your department has no qualified candidates to suggest for inclusion in the Assistant Accounts Officer panel for the year 2019 – 2020 and the panel will be finalized accordingly.

No extension of time will be given since the period to approve the panel is very short.

- (8) All the particulars furnished in the Proforma should be flagged on the relevant pages where the entries are made in the Service Register of the individual.
- (9) A Certificate to the effect that the proposals are submitted to the Commissionerate in respect of all eligible persons and that no qualified one has been left over in the proposals shall be furnished in Proforma D. If there is no eligible person for consideration for the panel, a "NIL" report shall also be furnished without fail.
