**CIRCULAR**

**Sub:** Public Services – Tamil Nadu State Treasuries and Accounts Services – Class IV Officers (Assistant Accounts Officer) panel – Proposals from other Departments – Requesting post confirmation from respective Departments – Reg.

In the reference 2<sup>nd</sup> cited, proposals have been called for from the Subordinate Officers of this department and other Head of Departments to propose eligible candidates for inclusion in the Class IV Officers (Assistant Accounts Officer) panel for the year 2019-2020. Initially it has been requested to send the proposal to this office on or before **17.04.2020**. The same has been further extended up to **15.05.2020** due to COVID-19 issues.

As per rule 3(g) of the Special Rules for the Tamil Nadu State Treasuries and Accounts Services no department shall have a representation of more than 3 times the Combined Cadre Strength of the post of Assistant Accounts Officer, Accounts Officer and Chief Accounts Officer in each department.

In this regard, the Government (Finance (T&A-I) Department) in their **Letter No. 14958/T&A-I/2019-1, Dated 30.05.2019**, have instructed this department to clarify and confirm as to **whether the deputation posts are exclusively reserved for the Asst. Accounts Officer, Accounts Officer and Chief Accounts Officer of Treasuries and Accounts Department. If so, the said posts should be included in the cadre strength for the purpose of calculation of Combined Cadre Strength of each department.**

As we prepared the first AAO panel after receiving above clarification from Govt., it has been requested to other departments vide ref.1<sup>st</sup> cited to **clarify as to whether the deputation posts of Asst. Accounts Officer, Accounts Officer and Chief Accounts Officer in their department are exclusively reserved for Treasuries and Accounts Department. If so, the same may be confirmed along with post sanctioned G.Os to work out the combined cadre strength and to calculate their departmental representation for consideration of their proposal in this panel.**

Consequently, proposals have been received from Subordinate Offices of this department and other Head of Departments to recommend eligible candidates for inclusion in the above panel.

After careful examination of all proposals, it has been addressed through D.O letter to clarify and confirm the deputation posts in concerned departments which are exclusively reserved for T&A Dept., along with post sanction G.Os / Board Resolutions, as the case may be, on or before **22.05.2020** since the timeline for finalization of AAO Panel for the year 2019-2020 was very short. Further it is also informed that if no reply has been received in this regard, the proposals from other departments cannot be considered for the Assistant Accounts Officer panel for the year 2019-2020 and the same will be finalized with available records. But no reply has been received from any of the offices on or before the date mentioned above and the seniority list has been finalized based on available records by including Superintendents / S.T.Os from Treasuries and Accounts Department. Accordingly the list has also been published for claims and objections in our official website.

Subsequently we have received reply from some of the departments on later date wherein the relevant Documents / G.Os / clarifications issued by the competent authority, required for consideration of the proposals have not been furnished.

However, we will consider the proposals from other departments in the panel of Assistant Accounts officer for the year 2020-2021 for which the crucial date is **15.06.2020 subject to the confirmation of exclusively reserved posts for Treasuries and Accounts Department along with necessary supporting documents from the competent authority i.e. concerned administrative department of Secretariat by whom the post has originally been sanctioned.**

In view of post protection and to avoid reversion of officials on deputation from T&A Department, it is necessary to obtain confirmation and post sanction G.Os from other departments as instructed in the Government **Letter No. 14958/T&A-I/2019-1, Dated 30.05.2019**. The Govt., (Finance Department) is also insisting us to furnish post sanction G.Os for all permanent, temporary and newly created posts to approve the estimates of panels from Accounts Officer to Additional Director for which Govt. (Finance Dept.) is the estimate and panel approving authority.

It is also noticed that in many of the post sanction G.Os from other departments, the posts of Assistant Accounts Officer, Accounts Officer and Chief Accounts Officer are not specifically earmarked for Treasuries and Accounts Department as they have been sanctioned / ordered for retention from old establishment at the time of inception of respective departments.


Therefore, it is hereby requested to all the heads of departments where the officials from T&A Dept. are holding the posts of AAO, A.O and CAO on deputation, to obtain necessary confirmation from their respective administrative department of Secretariat by whom the post has originally been sanctioned, for exclusive reservation of concerned posts to Treasuries and Accounts and forward the same to this office as early as possible so as to consider your proposals in ensuing panels of Assistant Accounts Officer in T&A Department.
