The issue of notifying more than one Public Information Officer has been examined considering the increase in number of applications received in this Department and it has been decided to notify the Under Secretaries as Public Information Officers to make available the information on the subjects dealtwith by them and the Sections Officers concerned with the subjects as the Assistant Public Information Officers. Accordingly, in supercession of the orders issued in the G.Os read above the Under Secretaries and Section Officers in the Department as detailed in the annexure are hereby appointed as Public Information Officers and Assistant Public Information Officers under Right To Information Act to make available the information on the subjects dealtwith by them.

4. The Deputy Secretary (OP) shall function as the Appellate Authority. The Public Information Officers shall furnish monthly periodical reports and annual reports as required under section 25(3) of the Right To Information Act to OP I section for consolidation.
