Micro, Small and Medium Enterprises Department – Implementation of Centrally Sponsored Scheme namely "Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME)" in Tamil Nadu up to 2024-2025 under Micro, Small and Medium Enterprises Department - Change of Nodal Department / State Nodal Agency (SNA) / State Nodal Officer (SNO) and reconstitution of State Level Approval Committee (SLAC) / District Level Committee (DLC) – Orders - Issued.

ORDER:

In the Government Order first read above, orders have been issued to authorize the Director of Agricultural Marketing and Agri Business as State Nodal Agency (SNA) to implement the New

Centrally Sponsored Scheme namely Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) in Tamil Nadu from 2020-2021 to 2024-2025 and State Level Approval Committee (SLAC) and District Level Committee (DLC) have been constituted with their functions and responsibilities in implementation of a Centrally Sponsored PMFME Scheme. The Tamil Nadu Agricultural University (TNAU), Coimbatore is also nominated as a State Level Technical Institution (SLTI).

2. In the Government Order second read above, orders have been issued for transferring the schemes and institutions relating to Food Processing, including the Pradhan Mantri Formalization of Micro food processing Enterprises (PMFME) scheme from Agriculture and Farmers Welfare department to the management of Micro, Small and Medium Enterprises Department.

3. In the letter third read above, the Agriculture Production Commissioner and Secretary to Government, Agriculture and Farmers Welfare Department has requested the Micro, Small and Medium Enterprises Department to pursue the following action, in respect of implementation of Pradhan Mantri Formalization of Micro food processing Enterprises (PMFME) Scheme:-

- (a) Designating Micro, Small and Medium Enterprises Department as Nodal department at Government level and Secretary to Government, Micro, Small and Medium Enterprises Department as State Nodal Officer to oversee the implementation of Pradhan Mantri Formalization of Micro Food Processing Enterprises Scheme.
- (b) Modifying State Nodal Agency, as finalized by Micro, Small and Medium Enterprises Department instead of Department of Agricultural Marketing and Agri Business.
- (c) Modifying State Level Approval Committee and District Level Committee with members as finalized by Micro, Small and Medium Enterprises Department.
- (d) Designating appropriate official of Micro, Small and Medium Enterprises Department as District Nodal Officer to implement the scheme at District level.

4. In the letter fourth read above, the Industries Commissioner and Director of Industries and Commerce has sent a proposal to Government to issue necessary orders approving the following amendments / changes in the Government Order first read above:-

- i. Designating the Micro, Small and Medium Enterprises Department as Nodal department at Government level.
- ii. Designating the Commissionerate of Industries and Commerce as State Nodal Agency (SNA) and Industries Commissioner and Director of Industries and Commerce as State Nodal Officer (SNO) to oversee the implementation of Pradhan Mantri Formalization of Micro food processing Enterprises (PMFME) scheme.
- iii. Designating Secretary to the Government, Micro, Small and Medium Enterprises Department as the Member Secretary of the State Level Approval Committee in lieu of Agricultural Production Commissioner & Principal Secretary to Government, Agriculture Department.
- iv. Regional Joint Director, Chennai as member secretary for the District Level Committee in respect of Chennai District and General Manager, District Industries Centres in respect of all other districts.
- v. Designating the functional manager of District Industries Centres / Regional Joint Director office as notified by the Industries Commissioner and Director of Industries and Commerce as the District Nodal Officer.

5. After detailed examination, the Government accept the proposal of the Industries Commissioner and Director of Industries and Commerce and issue following orders:-

- i. The Micro, Small and Medium Enterprises Department shall be designated as "Nodal Department at Government level" to implement the New Centrally Sponsored Scheme, namely "Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) in Tamil Nadu.
- ii. The Commissionerate of Industries and Commerce shall be designated as "State Nodal Agency (SNA)" and the Industries Commissioner and Director of Industries and Commerce is designated as "State Nodal Officer (SNO)" to implement the New Centrally Sponsored Scheme namely "Pradhan Mantri Formalization of Micro Food Processing

Enterprises (PMFME) in Tamil Nadu with the roles and responsibilities as envisaged in the Government Order first read above.

- iii. The State Level Approval Committee (SLAC) shall be reconstituted as per the following composition and with functions / responsibilities as envisaged in the Government Order first read above:-
