**ORDER:**

In the Government Order first read above, the subject relating to "Mines and Minerals" were separated from Industries, Investment Promotion & Commerce Department and a new department called Natural Resources Department was created.

2. In the Government Order second read above, amendments have been issued to the Tamil Nadu Business Rules, 1978, wherein certain subjects related Natural Resources in "Industries Department" were re-allotted to "Natural Resources Department" and the subject related "Sugar Industry" was re-allotted to Agriculture and Farmers Welfare Department. Further, it has been ordered to re-allot the subject "Air Craft and Air navigation" from Transport Department to Industries Department.

3. In the Government Order third read above, among other posts, sanction is accorded for creation of one post of Additional Chief Secretary to Government, Natural Resources Department in the Chief Secretary grade of Indian Administrative Service, for a period of one year with effect from the date of appointment or till the need for it ceases, whichever is earlier. Subsequently, Thiru. K.Phanindra Reddy, IAS, Additional Chief Secretary to Government, Transport Department has been ordered to hold full additional charge of the post of Additional Chief Secretary to Government, Natural Resources Department.

4. The Industries, Investment Promotion & Commerce Department has now requested to transfer 27 posts, from that Department to the newly created Department called Natural Resources Department and to create 22 posts in Industries, Investment Promotion & Commerce (3 posts), Natural Resources (16 posts) and Agriculture – Farmers Welfare (3 posts) Departments.

5. The Government after careful consideration, ordered that the posts mentioned in column (3) of Annexure to this order, are retained in Industries, Investment Promotion & Commerce Department and the posts mentioned in column (4) of Annexure to this order, are transferred from Industries, Investment Promotion & Commerce Department to the newly created Natural Resources Department. The posts mentioned in columns (5),(6) & (7) are created in Industries, Investment Promotion & Commerce, Natural Resources and Agriculture – Farmers Welfare Departments respectively.

6. The incumbents of the posts sanctioned / created in para 5 above is eligible to draw Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and Other Allowances as admissible under the orders in force.

7. The expenditure of the Industries, Investment Promotion & Commerce Department shall be debited under the following Head of Account:-

8. The expenditure of the Natural Resources Department shall be debited under the following Head of Account:-

“3451 – 00 – Secretariat – Economic Services – 090 Secretariat – State’s Expenditure – AY Natural Resources Department – 301 Salaries

(IFHRMS DPC: 3451 00 090 AY 30100)”

9. The expenditure of the Agriculture – Farmers Welfare Department shall be debited under the following Head of Account:-

3451 – 00 Secretariat – Economic Services – 090 Secretariat – State’s Expenditure – AB Agriculture and Farmers’ Welfare Department – 301 Salaries
