ORDER:

In the Government Order first read above, Notification were issued to the effect that Cyber Crime Cell of Intelligence and Security Organisations established by the Government of Tamil Nadu shall not apply the Right to Information Act, 2005. Subsequently, necessary Gazette Notification has been issued in the reference second read above and placed before the State Legislative Assembly.

- 2. Based on the request received from the Director General of Police / Head of the Police Force, the Government after careful consideration have decided to issue the following amendment to the said Government Order first read above:
- 3. The following Notification shall be published in the <u>Tamil Nadu Government</u> Gazette:-

NOTIFICATION

In exercise of the powers conferred by Sub-section (4) of section 24 of the Right to Information Act, 2005 (Central Act 22 of 2005), the Governor of Tamil Nadu hereby

makes the following amendment to the Public Department Notification No.II (2)PUEL/778(c)/2005 published at page 1 of Par II- Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated the 14th October, 2005.

2. It shall be deemed to have come into force on the 14th October, 2005.

AMENDMENT

In the said Notification, for Serial No.11 and the corresponding entries relating thereto, the following Serial No. and the Corresponding entries relating thereto shall be substituted namely:-

"11. Cyber Crime Wing and its units, namely:-

- (i) Cyber Crime Wing Headquarters, Chennai (comprising of State Cyber Command Centre, State Cyber Crime Investigation Centre & Cyber Arangam);
- (ii) Cyber Regional Labs at Tamil Nadu Police Academy, Chennai City, Coimbatore City, Madurai City, Trichy City and Crime Branch Criminal Investigation Department; and
- (iii) Cyber Crime Police Stations in Districts / Cities / Special Units [Economic Offences Wing, Crime Against Women and Children, Crime (Narcotics Intelligence Bureau.CID / Intellectual Property Right Enforcement Cell)]."
